



## President's Report – AGM, 26 August 2020

This has certainly been a year to remember and we have all faced the need to adjust to a new reality. With reports like this, the usual pattern is to touch on key points of note and conclude by thanking everyone. However, this year I am changing that approach. Firstly, I want to acknowledge our amazing members in general and our Board members in particular. They not only adjusted to the reality brought about by Covid-19 restrictions but led the way in proving how spirit and spiritual energy works across different media and knows no boundaries in time or space. Mediums from around the country, including many of our Board members, bravely put their hands up to work on a virtual platform and hopefully they are as proud of themselves for what they achieved as I am. This year, we are fortunate to be in the position of having two nominations for new Board members (Lyn Herriot and Amanda Cartridge). Lyn is based in Porirua and Amanda in Selwyn. We are always keen to encourage new people onto the national committee as they provide fresh ideas and energy, and future growth.

So, having started this report by acknowledging our members and wonderful Board members, I would like to finish off by noting the contribution from Rod Foster, our financial reviewer. Rod has made the decision to retire from this line of work which goes as far back as 1976 when he was involved with the Upper Hutt Spiritualist Church and then later with Petone Spiritualist Church. In addition to Petone and Upper Hutt, Rod has reviewed the finances for other spiritualist churches, both in the greater Wellington region and elsewhere. We will all miss Rod's input, and wish him and his family well for the future.
